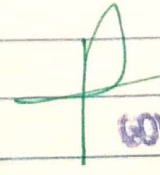

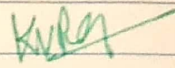

1) To conduct awareness programme on Consumerism, Rights, Responsibilities and duties of the Consumers among the students.

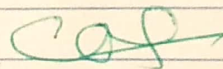

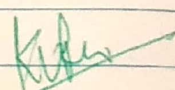
