Hence, the college is attempting a serious commitment to restore the eco-friendly and sustainable environment for the wellbeing of the stakeholders.

**Procedure:**

College is exposed and experiencing Various types of pollutions

As a part of green initiatives of the campus our college is focusing mostly on three core areas such as, restricted entry of automobiles, constructing and maintaining pedestrian friendly path ways and ensuring the greenery within the campus.

**Restricted entry of Automobiles**

- Campus is divided into different zones like parking, limited parking and vehicle free zones.
- These zones are planned to accommodate the huge strength of the college without interfering in the congenial environment of the college. As the strength of the college is 5000 plus, the college made different places as parking zones, limited parking zones to accommodate the needs of the entire staff and students. Despite this demand, we are maintaining some areas as vehicle free zones to minimize the origin of various types of pollutions.
- Every second Friday of the month is declared as no vehicle day.

- Creating awareness about the vehicle restricted area by using various modes of communication like public address system, displaying in the notice boards, assemble and using sign boards.

- Intimate various government policies related to automobile vehicle usage.

**Use of bicycles**

- Motivating the students to use bicycles as their main mode of transport
- Creating awareness about the physical fitness benefits of the bicycle usage
- Using bicycle as transport purpose within the campus to reduce air, noise pollutions, carbon emissions and traffic congestion.

**Pedestrian friendly pathways**

1. The road starting from main entrance to the JKC block is meant for walking only. Hence vehicles (including bicycles) are not allowed along that road, except the vehicles of differently abled students
2. Due to the prevailing Covid-19 situation, students will not allow in groups along the pathways and also in other areas of the campus
3. A 'NO ENTRY' board will be displayed at the starting of the pathway and no student or staff will be allowed with vehicles beyond the no entry board.
4. These instructions will be communicated to the watch man at the gate and he will restrict the entry if any one bypass the rules.

- Maintenance of separate dustbins for degradable and non -degradable waste by the college administration. Ensuring the same under the supervision of class representatives.
- Checking the bags especially lunch bags of the staff by the committee on no plastic day and for checking students lunch bags class representatives are responsible.
- Conducting informal sessions to educate the hazards of plastic.
- Regular monitoring of existing landscape by the department of botany.
- Include green audit in the co-curricular activities of the botany department.
